Mandan Park District Board Minutes August 13, 2012

The Board of Park Commissioners duly met in regular session on Monday, August 13, 2012 at Mandan City Hall. Those present were President Arenz, Vice President Porter, Commissioners Allan, Knoll and Legal counsel Arlen Ruff. Commissioner Keller was absent.

President Arenz called the meeting to order at approximately 5:30PM, CDT. President Arenz asked if there were any changes or corrections to the minutes of July 9, 2012 regular meeting and the July 18, 2012 special meeting. A motion giver by Commissioner Porter, seconded by Commissioner Knoll, to approve the minutes as stated, and the motion carried the approval of the board.

Unfinished Business, Director Higlin presented the approval for increasing matching funds with the Mens Softball Association for the multi-purpose building at the softball complex. Motion to approve was by Vice President Porter seconded by Commissioner Allan, to share the \$300,000 project with softball, with the edits to the floor plan as Director Higlin presented. A roll call was taken with the board members present voting yes, motion passes.

New Business #1, consider for approval updating ordinance 21-09-13 and introduction of land dedication ordinance, Director Higlin proposed to raise the single family permit to \$500.00, multi-family permit to \$250.00 per unit with a minimum of \$500.00 and commercial building permit to \$1000.00. The second option would be land dedication, third option fees and dedication. It has been 30 years since this has been address. A motion was given by Commissioner Knoll, seconded by Vice President Porter to approve the fee for a single family unit to \$500.00, multi family unit to \$250.00 per unit and the commercial building to \$1000.00. Commissioner Knoll stated to allow Director Higlin to do research on land dedication. A roll call was taken with board members present voting yes, motion passes.

New Business #2, discussion on future land acquisition and funding options, Director Higlin proposed acquiring land in the Northwest area. A \$500,000.00 budget \$200,000 towards land and development with \$300,000.00 going to the Softball Complex. A motion was given by Commissioner Knoll, seconded by Commissioner Allan to approve \$500,000 to finance with \$200,000.00 going towards land acquisition. Vice President Porter asked for clarification on motion to include park development. Commissioner Knoll amended the motion to include park development. President Arenz asked Legal counsel Ruff if he was in agreement with the change of motion. Legal counsel Ruff said yes. A roll call was taken with board members present voting yes, motion passes.

New Business # 3, Consider for approval to attend the NRPA conference. Director Higlin proposed approval for Commissioner Keller, Superintendent Zerr and Director Higlin to attend the National Parks & Recreation Convention in Anaheim CA, October 16-18. Commissioner Knoll made a motion to approve, seconded by Vice President Porter. A roll call was taken with board members present motion yes, motion passes.

New Business #4, Consider for approval to attend the World Water Park Association Convention. Reid Katzung proposed approval to attend the World Water Park Association Symposium & Trade show in Las Vegas, NV, October 2nd - 5th. A motion was given by Vice President Porter, seconded by Commissioner Knoll to approve. A roll call was taken with board members present yes, motion passes.

Staff and Commissioner Reports, Director Higlin stated that the financials looked good this year. Gaye Niemiller had nothing new to report. Reid Katzung stated that Raging Rivers had 7 full days left and the following 2 weekends with shortened hours. Thanked LeAnn and Brian for the free coverage they supplied this summer. Ice Arena scheduling is underway and interest has picked up already. Mike Zerr stated that summer softball is done. Fencing is going on, slow with some niches here and there. Three hundred cubic yards of engineered wood fiber were put down and were able to fill out three more parks this year. Dave Frueh stated that he is working on the National Softball Tournament to be held September 7th - 9th, 2012. Today was the final day for voting for the movie in the park. The winner is "We bought a Zoo", will be showing on September 15th, 2012 at Memorial Ball Park. Director Higlin and Kara Haff purchased a new screen. Vice President Porter asked if they have volunteers set up for the tournament. Dave indicated that Jack and Ron are working on the volunteers. Brad Olson stated that we went through the hottest July ever and the golf course is still in very good condition. He thanked his staff for doing such a good job with keeping it look so good. New men's golf champion this year, his name is Scott Bergen and the new lady's champion is Kristy Horner.
