## Mandan Park District Board Minutes July 9, 2012

The Board of Park Commissioners duly met in regular session on Monday, July 9, 2012 at Mandan City Hall. Those present were President Arenz, Commissioners Porter, Keller, Knoll, and Legal Counsel Arlen Ruff. Commissioner Allan was absent.

President Arenz called the meeting to order at approximately 5:30pm, CDT. President Arenz asked if there were any changes or corrections to the minutes of the June 11, 2012 regular meeting and June 14, 2012 special meeting, Commissioner Knoll stated that she was not present at the June 14 meeting, a motion given by Commissioner Keller, seconded by Commissioner Porter, to approve the minutes as stated, and the motion carried the approval of the board.

President Arenz asked if there are any additions to the agenda, Commissioner Porter asked that we add commissioner compensation.

President Arenz wanted to recognize and thank Bruce Brucker for eight years of service on the park board and award him his lifetime golf card. Mr. Brucker was not in attendance.

New Business #1, Golf Operations Manager; Brad Olson introduced Garrett Schultz as the new golf superintendent for Prairie West and Municipal Golf Course.

New Business #2, Director Higlin present for renewal Mandan Aquatic Center and Gymnasium agreement with the Mandan School District for two years. Commissioner Keller motioned approval and seconded by Commissioner Knoll. Roll call vote was taken with all commissioners voting yes.

New Business #3, Director Higlin presented Matching Grant application for our second round of funding. Director Higlin recommended Mandan Touchdown Club awarded \$1,250 for new helmets and Mandan Hockey Club \$1,250 for new tables and chairs at the All Seasons Arena. Commissioner Porter moved to approve as recommended, seconded by Commissioner Keller. Roll call vote was taken with all commissioners voting yes.

New Business # 4, President Porter explained the responsibilities of being president and that the president's compensation should be higher compared to fellow commissioners. Commissioner Porter motioned to increase the president's salary to \$2,400, seconded by Commissioner Knoll. Roll call vote Commissioner Porter, Keller, and Knoll voted yes. President Arenz did not vote.

Staff and Commissioner Reports, Park Superintendent Mike Zerr recapped the 4<sup>th</sup> of July rodeo and McQuade softball tournament. Golf Operations Manager Brad Olson updated the board on the increase volume of both courses and the impacts to the financial statement. Commissioner asked if we are going to talk about the YMCA project at the retreat. Commissioner Knoll asked if we have heard if Papa's Pumpkin Patch was going to return to Mandan this fall. Director Higlin stated that he would contact Dave Pearce about returning to Mandan.

The next agenda item was approval of the monthly bills, a motion by Commissioner Knoll, seconded by Commissioner Keller, to approve the monthly bills as stated. A roll call vote was given at this time, with all board members present voting yes. The motion carried the approval of the board. They are as follows:
