Mandan Park District Board of Minutes January 14, 2013

The Board of Park Commissioners duly met in regular session on Monday January 14, 2013 at Mandan City Hall. Those present were President Arenz, Vice President Porter, Commissioners Allan, Keller, Knoll and Legal Counsel Arlen Ruff.

President Arenz called the meeting to order at approximately 5:30pm, CDT. President Arenz added an agenda item #4 for Discussion on the north land purchase; he then asked if there were any changes or corrections to the minutes from the December 10, 2012 regular meeting. Vice President Porter offered an amendment in Unfinished Business #2 the dollar amount needed to be corrected from \$30,000 to \$300,000. A motion was giving by Commissioner Knoll, seconded by Commissioner Keller, to approve the minutes as stated, and the motion carried the approval of the board.

Unfinished Business: nothing for discussion

New Business #1: Golf Manager, Brad Olson, presented the board for approval the raising of the fee structure for the 2013 season at both golf courses for the Mandan Park District. Motion was made by Vice President Porter to adopt the 2013 Golf Rates as presented, seconded by Commissioner Keller. A roll call vote was taken with all commissioners voting yes. Motion passes.

New Business #2: Golf Manager, Brad Olson presented the board for approval to dispose of or sell unused golf course equipment. Motion was made by Commissioner Knoll for the liquidation of equipment, seconded by Commissioner Keller. A roll call vote was taken with all commissioners voting yes. Motion passes.

New Business #3: Director Higlin presented the board for approval to enter into an agreement with ICON architect to do a facility audit of the All Seasons Arena for mechanical issues and to get true and accurate costs for renovation and expansion needs. To enter the agreement \$10,000 is required. \$5,000 would come from the Mandan Hockey Club and \$5,000 from the Park District, which has already been budgeted. Vice President Porter made a motion to approve the \$10,000 contract, seconded by Commissioner Knoll. A roll call vote was taken with all commissioners voting yes. Motion passes.

New Business #4: Director Higlin presented to the board the MDU proposed pipeline which will run along the northeast border of the new park land. Director Higlin asked for approval of the current location of the pipeline and asked MDU to present to the park board if deviations are made to this proposed location. Commissioner Keller made a motion to acknowledge the easement of the MDU pipeline, with the knowledge that if something changes it will be presented to them, seconded by Commissioner Allan. A roll call vote was taken with all commissioners voting yes. Motion passes.

Staff and Commissioner Reports: Director Higlin informed the board that the Legislative watch issues he is dealing with will be email out to them each week, Gaye Niemiller did not have anything to report at this meeting. Reid Katzung noted that during the public skating Winter Days the All Seasons Arena ran out of rental skates giving it quite the turnout! We booked our first group for this summer, Dakota Horizon Girl Scouts booked today for 2013 and last summer they had 228 girls that show up for that. Mike Zerr informed the board that we received our 4100 mower last week and its up, running and ready to go. Dave Frueh stated the volleyball tournament went very well. He informed the board of the New Year's Special at Raging Fitness that's doing very well and we are getting a lot of new members signing up and trying out the facility. We currently have 350 active members in the fitness center. Brad Olson did not have anything to report at this portion of the meeting as he spoke earlier. Commissioner Allan brought up the topic of a cross country ski trail. He said he has had many inquiries on the feasibility of that, where would it be located, what kind of equipment would be needed, etc. Brad Olson imputed that the equipment we would need would be a groomer & something to pull the groomer with. He stated they could make a trail over at the Municipal Golf Course since there is already a warming house and staffing already on hand. There is a possibility of getting a grand for the equipment, which is being looked into. It is also being discussed that we go in with Morton County on the grant and share the equipment with them as well. President Arenz wanted to update everyone on the Rec Center/YMCA building. Where we are at today, Sanford is in the middle of their budgeting process for this coming year. Sanford does want to participate somehow but no dollar amount has been set with the YMCA and Park District. Two private parties are interested in building the facility but nothing has been determined as of yet. After the building process they would lease it back to the Park District if it may be or the YMCA and possibly Sanford.

The next agenda item was approval of the monthly bills, a motion by Commissioner Knoll, seconded by Commissioner Keller. Roll call vote was taken with all commissioners voting yes. Motion passes.
