Mandan Park District Board Meeting Minutes March 14, 2016

The Board of Park Commissioners duly met in regular session on Monday, March 14th, 2016 at Ed "Bosch" Froehlich Meeting Room, City Hall. Those present were President Arenz, Vice President Knoll, Commissioner McPherson, and Commissioner Hatzenbuhler.

President Arenz called the meeting to order at approximately 5:30 pm, CDT. President Arenz asked for approval of the minutes for February 8, 2016 regular meeting. Motion was made by Vice President Knoll, seconded by Commissioner Hatzenbuhler. Motion passes.

Public Communication: Director Higlin introduced Jasmine, a 4th grade student from Lewis and Clark. She raised \$200 by selling cookies and lemonade and gave \$100 to the Mandan Park District and \$100 to her school to help pay for the vandalism at Eagles Park and Lewis and Clark. President Arenz presented to her a season pass for Raging Rivers. A season pass to Raging Rivers was given to her by President Arenz for helping the Mandan Park District.

Unfinished Business:

Section 1.) Consider for approval refinancing Raging Rivers revenue bond. Director Higlin introduced Mike Manstrom with Dougherty & Company who is responsible for the refinancing of Raging Rivers. Mike Manstrom stated Dougherty did the initial 2009 bonds. Rates have come down so there is an opportunity to save by refunding the existing bonds with the proceeds of the new bonds. The old bonds remaining maturities I had coupons from a 4.1% out to a 5.3 % in 2029. We are refunding those higher rates with interest rates on today's bonds starting at .85%, so it is under 1% going out to 2.60%, so it is significantly less than the existing higher rates. If the resolution is passed, we will lock up the interest rates, money will be in the Park Districts account by March 29, and payment will be due by May 1, 2016. The Park District would save approximately \$396,181 and we have reduced the maturity from 2029 to 2027. So it will be paid off 2 years sooner. President Arenz stated with the saving of \$300,000 we chose to keep our payments relatively the same as they were prior to this refinancing and pay it off sooner rather than keeping our amortization longer and lower payments. Motion was made by Commissioner McPherson, seconded by Vice President Knoll. Motion passes.

New Business:

- Section 1.) Consider for approval of 2016 district policies
 - a.) Parks Policy. No fireworks allowed on Mandan Park property has been added to the policies. Motion was made by Vice President Knoll, seconded by commissioner Hatzenbuhler. Motion passes.
- Section 2.) Approval to solicit for Human Resource Generalist services. This
 individual would not be a full time or part time employee for the Mandan Park
 District; he/she would be an independent contractor. Motion was made by
 Commissioner McPherson, seconded by Commissioner Hatzenbuhler. Motion
 passes.

Section 3.) Commissioner Reports

- Director Higlin stated that March 24th is the bid opening for the Sports Complex at NW contracting's office. A special meeting will have to be held to approve the bids and bid package 1. Also a meeting will be held tomorrow morning and tomorrow afternoon with the high school administration and coaches. The vendors are flying in for both turf and track vendors. We have two different representatives for track and two representatives for turf to come in and educate the coaches and the administration along with staff from the park district on the selection and different types of option because there are many different layers and levels associated with each one. And try to get a better understanding so when we do open bid package 2 we can make a sound decision based on the turf and track material. Attorney Ruff stated that the purchase agreement for the land is in place, we have an addendum to extend the closing. There is a draft of a development agreement for the adjoining property and our property for services that we are going to be using; there is a draft of that that's been put together by attorney Sean Smith. It is almost complete, only a few minor changes to it. Closing is set for April 8th.
- Kara Haff, Raging Rivers/Aquatics manager stated that Raging Rivers is about 90 days out from opening that is set for May 31st. Over 700 passes have been sold. Compared to 988 last year. There will be one more Easter push at the \$110 level then they will go up to \$140 for the season.
- Mike Zerr, parks manager stated that about half the concrete has been removed from the tennis courts, half to go yet.
- Dave Frueh, Recreation manager stated this is the last week of ice for the All Seasons Arena. Then that area will be open for other practices.
- o Brad Olson, golfing manager state the golf course opened Saturday.
- o Director Higlin stated that there will be a camera system at Eagles Park.

Authorization of payment of the monthly bills. Motion made by Vice President Knoll, seconded by Commissioner McPherson. Motion passes.
