Mandan Park District Board Meeting Minutes April 10, 2017

The Board of Park Commissioners duly met in regular session on Monday, April 10, 2017 at Ed "Bosch" Froehlich Meeting Room, City Hall. Those present were President Arenz, Vice President Knoll, Commissioner Hatzenbuhler, Commissioner Meschke and Commissioner McPherson.

President Arenz called the meeting to order at approximately 5:30 pm, CDT. President Arenz asked for approval of the minutes for the March 13, 2017 regular meeting. Motion was made Commissioner McPherson, seconded by Vice President Knoll. Motion passes.

Unfinished Business:

1. Discussion on potential changes to the locker room building. Director Higlin stated that the cost to add two additional showers is \$16,000 on the low end or another \$10,000 on the high end. It is recommended to stay within the \$623,000 that was approved last month and make the architect and the construction manager add the two showers in and make it work within the existing budget. During the construction meeting they felt like they could do that with reducing the size of the bump out.

New Business:

- 1. Restructure of Recreation Department. Dave Frueh, Recreation Manager announced Naomi Erdahl was promoted to Assistant Recreation Manager and Kendra Weigel was hired as the new Raging Rivers Manager. Casey Johs, Recreation Assistant is currently supervising the aquatic center and will be introduced to programs this summer.
- 2. Consider for approval engineering services for Old Red Trail. Director Higlin stated that the City of Mandan and NDDOT is requesting that the road have turning lanes. The intent is to have a 3 way developer's agreement with Tesoro 35%, Mandan Parks 55%, and Mandan 94 Group 10%. It is recommended to hire KLJ for engineering services for Old Red Trail improvements. Motion to approve up to 55% of allocation was made by Commissioner Hatzenbuhler, seconded by Vice President Knoll. Motion passes. Motion was made to hire KLJ for engineering services for Old Red Trail improvements by Vice President Knoll, seconded by Commissioner Hatzenbuhler.

3. Commissioner/Staff Reports

- Kendra, Raging Rivers Supervisor stated Raging Rivers will open June 1, 2017
- Dustin Fleck, Park Superintendent stated that the old Raging Fitness area is almost completed with a conference room, storage and offices. All Seasons Arena's bleachers are unattached and ready to be moved to the sports complex.
- Naomi, Assistant Recreation Manager stated summer staff is being hired for summer programs, Raging Rivers and the aquatic center.
- Dave Frueh, Recreation Manager stated that evening baseball will be starting soon. The MAC program is 100% full. It will be held at Lewis & Clark this year.

Authorization of payment of the monthly bills. Motion was made by Commissioner McPherson, seconded by Vice President Knoll. Motion passes.
