## Mandan Park District Board Meeting Minutes January 09, 2017

The Board of Park Commissioners duly met in regular session on Monday, January 9, 2017 at Ed "Bosch" Froehlich Meeting Room, City Hall. Those present were President Arenz, Vice President Knoll, Commissioner Hatzenbuhler, Commissioner Meschke and Commissioner McPherson.

President Arenz called the meeting to order at approximately 5:30 pm, CDT. President Arenz asked for approval of the minutes for the December 12, 2016 regular meeting. Motion was made by Vice President Knoll, seconded Commissioner Hatzenbuhler. Motion passes.

#### **Unfinished Business:**

- 1. Update on the Starion Sports Complex. Director Higlin stated that the record level of snow will make it difficult for the exterior of the Sports Complex. In April or May we will have a better idea on where we are at depending on the weather and the ability to get to the external part of the building. There are no concerns with the main building. The concern is getting the track in. The ground needs to be 45 degrees for it to cure. The total payments year to date is roughly 5 million dollars. In construction costs there is about 17.5 million left before completion. The guaranteed maximum price was \$22,400,000 which included the parking lot that was added. With the locker room add-on the new maximum price is 24,946,000. Total Contingency remaining is 1,173,426.54. Starting in October the total sales collection for 2015 was around \$250,000. For 2016 for the entire year should be around 1.6 or 1.7 million dollars. The debt payments are around 1.1 million so an extra \$600,000 of extra revenue will be generated and will be put towards the debt.
- 2. Timeline of events for All Seasons Arena. Direct Higlin stated that the All Seasons Arena will be a wood floor with 2 courts that will have rubberized material. A court layout in which the tennis, volleyball courts and lines are centered on the basketball court. Want to get it completed by August 2018.

### **New Business:**

- Consider for approval paying off additional special assessment balance. Director Higlin recommended paying off some of the special assessments that have a higher interest rate to free up more debt space. The recommended amount to be paid off is \$1,852.72 & \$32,185.02. Motion was made by Commissioner Meschke, seconded by Commissioner McPherson. Motion passes.
