Mandan Park District Board Meeting Minutes January 13, 2020

The Board of Park Commissioners duly met in special session on Monday, January 13, 2020 at City Hall 205 2nd Ave NW in the Bosch Froelich room.

Attendees:

Park Commissioners: President Wade Meschke, Vice President Jason Arenz, Commissioners Chad Hatzenbuhler, Wanda Knoll and Miles Mehlhoff.

Park District Staff present: Director Cole Higlin, Park Superintendent Dustin Fleck, and Golf Operations Manager Brad Olson.

Legal Council: Arlen Ruff

President Meschke called the meeting to order at approximately 5:30pm, CDT.

<u>Public Communication:</u> No one appeared.

<u>Minutes</u>: Motion by VP Arenz and seconded by Commissioner Hatzenbuhler to approve the December 9, 2019 regular meeting. Motion passes 5-0.

<u>Item 1:</u> Director Higlin presented the 2020 park board monthly meeting dates and recognized holidays. Motion by VP Arenz to approve the 2020 Park Board and Portfolio meeting dates as presented. Seconded by Commissioner Knoll, motion passes 5-0.

<u>Item 2:</u> Director Higlin presented a proposal from JLG Architect to consider a joint feasibility study with the Mandan Hockey. The study would research opportunities to expand our locker room needs and dry land space. The cost of the feasibility study is \$2,000 and the cost would be shared equally between the Mandan Park District and the Mandan Hockey Club. Director Higlin stated that participating in the study does not commit the Park District to any financial commitment.

Nate Miller President of the Mandan Hockey Club presented the need for additional space for the increase enrollment. The Starion Sports Complex has had a huge impact in the community. In 2017 we increased our enrollment in the club and in 2019 we also increased our younger members. We are looking to improve and discuss among facility users that we can make improvements at the complex. The goal is to determine if we can construct and what the costs will potentially be to make this happen. President Meschke asked about practice times for USA hockey. Intro to hockey allows kids to come out for two weeks and get them on the ice for two weeks. This allows them a minimal commitment to help experience in this program. The Mandan Hockey Club has about a 50% retention, currently they have 262 skaters in the club. Commissioner Hatzenbuhler asked if they have talked to other users of the facility to see what their needs are. Once we get approval to complete the feasibility study and receive the cost estimates, we will determine if it's viable and bring those representatives into the discussions. Recreation and Facility Manager Dave Frueh discussed the need for additional space during core times during the day. If the school and U Mary hockey programs want to have permanent locker rooms to leave their stuff permanently, we will need additional locker rooms. U Mary is the only group that has dedicated locker rooms for their equipment, but have to move their equipment periodically to accommodate our locker room needs for larger events. Nate Miller stated another need is dry land space. The current space isn't large enough to accommodate our goals and increase skill level with strength training.

Commissioner Hatzenbuhler discussed additional facility needs such as work out space that has a benefit to the entire community. Nate Miller stated that we haven't thought that far in advance. Commissioner Hatzenbuhler stated that he is disappointed that the school district and U Mary are not included in the discussions. President Meschke supports the study and using tax payers dollars so soon since we just constructed the facility, I am hesitant to commit funds towards construction. Commissioner Knoll asked if the study would include a fitness center, currently it would not include a fitness center. Commissioner Hatzenbuhler asked Director Higlin if cost estimates will include utility cost estimates to our operations, currently it does not. Commissioner Hatzenbuhler asked are we going to see our subsidy increase with the additional space potentially being added. Director Higlin stated that the new proposed areas will not bring in any additional revenue and will add to the utility costs. Based on state wide ice arena operating budgets, many of them do require subsidy to operate.

President Meschke stated that the Sports Complex will never be a money maker and the goal is to maximize the facility. The deficit doesn't reflect the \$1.25 million upfront lease. We currently do not reflect the \$125,000 annual lease revenue annually as we received it upfront. If we reflected the \$125,000 in each operating year, the subsidy would look at lot different. So we need to keep that in mind when we talk about operating expenses for the Sports Complex. Recreation and Facility Manager Dave Frueh explained the amount each group rents in ice rent annually.

Commissioner Hatzenbuhler stated that the Park District will have very little to benefit for additions as we do not run any programs at the Sports Complex. Commissioner Mehlhoff stated that the study will determine if it's feasible to expand the footprint and there is a benefit to the Park District. Commissioner Knoll supports the study to determine if we are able to do anything in the future. Once the study is completed, then we can communicate with everyone that uses the facility to make sure we address all their needs. VP Arenz stated that he supports the study, sometimes we do too many studies when we all know the answers to what we want. VP Arenz doesn't support participating financially towards the project because the Park District has no direct benefit. The Mandan Hockey Club needs to determine how to fund the project on their own. Nate Miller stated that we are now able to host four tournaments this year compared to the old arena we couldn't host. Director Higlin recommended sharing the cost estimate of the study with the Mandan Hockey Club since it will be a document for the Park District to use in the future for strategic planning.

Motion by VP Arenz and seconded by Commissioner Knoll to approve the \$2,000 feasibility study shared equally with the Mandan Hockey Club. Motion passes 4-1; with Commissioner Hatzenbuhler voting no.

Item #3: Recreation & Facility Manager Dave Frueh presented the 2020 SSC ice rental agreement with the Mandan Hockey Club. The \$100,000 ice rental agreement runs on the calendar year and we support as presented. Commissioner Hatzenbuhler asked how much ice was rented last year compared to the agreement. Recreation & Facility Manager Dave Frueh stated they only used around \$96,000. Motion by VP Arenz and seconded by Commissioner Hatzenbuhler to approve the 2020 Mandan Hockey ice rental agreement. Motion passes 5-0.

Item # 4: Golf Operations Manager presented the 2020 golf rates for approval.
