Mandan Park District Board Meeting Minutes March 8, 2021

The Board of Park Commissioners duly met in special session on Monday, March 8, 2021, at City Hall, 205 2nd Ave NW in the Bosch Froelich room.

Attendees:

Park Commissioners: Vice President Jason Arenz, Commissioners Chad Hatzenbuhler, Jen Froehlich and Miles Mehlhoff.

Park District Staff present: Cole Higlin, Teri Welch, Dustin Fleck and Dave Frueh.

Legal Council: Arlen Ruff

Vice President Arenz called the meeting to order at approximately 5:30pm, CDT.

<u>Public Communication:</u> No one appeared.

<u>Minutes</u>: Motion by Commissioner Froehlich and seconded by Commissioner Hatzenbuhler to approve the February 8, 2021 regular meeting. Motion passes 4-0.

Item #1 Director Higlin provided an update on the feasibility study with ICON Architect firm on the Park Operations Maintenance Building. Director Higlin reviewed the information at today's Parks Portfolio meeting which included Accounting Manager Teri Welch, Park Operations Manager Dustin Fleck, Commissioner Miles Mehlhoff, Director Higlin, and ICON representative Lee Pierce. The study revealed that in order to bring the current building up to code, renovation cost is estimated at \$800,000 for a 1940's building. Director Higlin stated the Park Portfolio Committee recommends proceeding with a new 10,000 sq ft building not to exceed \$2 million with a fee of 7% from ICON. The current storage building will be used for overflow storage and we will replace the exterior metal siding to match the new building. Director Higlin provide a financial overview of how we could pay off current debt with cash reserves in the amount of \$525,000; this includes paying off Raging Rivers improvements, Sports Complex land, and Aquatic Center dehumidifer to prepare for potential new debt for the new maintenance building. We could use \$500,000 from the capital improvement fund to pay for expenses in 2021. This fall, we can decide if we want to use general fund reserves to reduce debt or take out a loan for the remaining balance of \$1.5 million. Timeline for design and bid is 4-5 months; we will have actual construction costs in August. Park Superintendent Fleck provided an overview of the maintenance area and recommends going north of his current shop while not affecting the Southside Master Plan for Faris Field. Motion by Commissioner Hatzenbuhler and seconded by Commissioner Froehlich to approve constructing a new 10,000 sq ft Park Operations Maintenance Building not to exceed \$2 million. Motion passes 4-0.

Item #2: Recreation & Facilities Manager Dave Frueh presented a bid summary for the 2022 ice resurfacer. The low bid was Olympia for \$107,025 with a trade in of the 2004 Olympia for \$10,000. Total cost to the district is \$97,025 and we sold naming rights to Schwan Buick GMC Cadillac for \$50,000. Motion Commissioner Mehlhoff and seconded by Commissioner Hatzenbuhler to approve Big Hill Services for \$97,025 including the trade in of the 2004 Olympia. Motion passes 4-0.

Item # 3: Director Higlin present the rough draft of the 2022-2023 strategic plan as our current strategic plan expires in 2021. Currently the leadership team and supervisors have participated in discussions for items to address while developing goals for their department. Director Higlin wanted Park Commissioners to review their portfolio and provide additional feedback on their goals and objectives for the district. Director Higlin would like recommendations emailed back to him by March 12; we would present the final document to the board for approval at our April 12, 2021 board meeting.

Authorization of payment of the monthly bills. Motion by Commissioner Mehlhoff and seconded by Commissioner Hatzenbuhler, Motion passes 4-0.
