Mandan Park District Board Meeting Minutes November 9, 2020

The Board of Park Commissioners duly met in special session on Monday, November 9, 2020 at City Hall, 205 2nd Ave NW in the Bosch Froelich room.

Attendees:

Park Commissioners: President Wade Meschke, Vice President Jason Arenz, Commissioners Chad Hatzenbuhler and Miles

President Meschke called the meeting to order at approximately 5:30pm, CDT.

Public Communication: No one appeared.

<u>Minutes</u>: Motion by Vice President Arenz and seconded by Commissioner Hatzenbuhler to approve the October 12, 2020 regular meeting. Motion passes 4-0.

<u>Item #1:</u> Director Higlin stated that we were approved reimbursement from the Coronavirus Relief Fund in the amount of \$8,500 of covid related expenses.

<u>Item #2:</u> Director Higlin updated the board on the demolition of Faris Field. The demolition expense is shared 50/50 with Mandan Public Schools. Our share is \$45,000 and demolition so far is about 50% complete. Director Higlin asked for approval to transfer restricted funds in the amount of \$333,000 from the general fund to the construction fund. These funds are still restricted, but allows us to have a true picture of our general fund dollars that are available. We still would need Park Commissioners approval to utilize these funds in the future and transferring funds does not commit us to moving forward with any project. Motion by Vice President Arenz and seconded by Commissioner Mehlhoff to transfer \$333,000 restricted funds dedicated for Faris Field improvements from the general fund to the construction fund. Motion passes 3-1; Hatzenbuhler voting no.

<u>Item #3:</u> Director Higlin presented the current Park District ordinances that the Mandan Police Dept currently has on file. The purpose of updating the ordinances is to make sure the meet NDCC and do not conflict with Mandan Park District policies and municipal ordinances that the police have on file. The timeline is to have Attorney Ruff review them, City Attorney Oster provide comment and then we will have two readings of the ordinances in January and February 2021.

<u>Item # 4:</u> Golf Operations Manager Olson requested approval to advertise a request for proposals for 90 golf carts, 5 utility vehicles, and 3 beverage carts. Motion by Commissioner Mehlhoff and seconded by Vice President Arenz to advertise the RFP; motion passes 4-0.

<u>Item # 5:</u> Director Higlin requested approval to advertise 2021 capital improvement items that were approved at our budget hearings. Motion by Commissioner Mehlhoff and seconded by Commissioner Hatzenbuhler. Motion passes 4-0.

<u>Item # 6:</u> Commissioner Reports: Discussion was held to explore adding additional lighting for safety at HA Kautzmann Park. Concern is the blind corner and street lights are on the opposite side of the street.

Authorization of payment of the monthly bills. Motion was made by Commissioner Mehlhoff and seconded by Commissioner Froehlich, Motion passes 4-0.
