Mandan Park District Board Meeting Minutes September, 2017

The Board of Park Commissioners duly met in regular session on Monday, September 11, 2017 at Ed "Bosch" Froehlich Meeting Room, City Hall. Those present were President Arenz, Vice President Knoll, Commissioner Hatzenbuhler, Commissioner Meschke and Commissioner McPherson.

President Arenz called the meeting to order at approximately 5:30 pm, CDT. President Arenz asked for approval of the minutes for the August 14, 2017 regular meeting. Motion was made Commissioner McPherson, seconded by Vice President Knoll. Motion passes.

Unfinished Business:

- Gene Kautzman, Carol Nitschke and Diane Lillis from the Kiwanis Club of Mandan presented a check in the amount of \$9,000 to the Mandan Park district for Youth Baseball, along with the final installment on the Universal Playground in the amount of \$4,000.
- Update on the Starion Sports Complex.
- Park Board Lifetime benefits policy. Jason Arenz, Park Board President stated that during the term of which an individual serves as commissioner for the Mandan Park District, the Commissioner, including the spouse and dependents, receive free use of all MPD programs and facilities. Lifetime usage is awarded only to those that are elected to a 2nd term, whether consecutively or not, and serve at least one full year of that 2nd term. All past and present (as of 01/01/18) MPD Commissioners are grandfathered into this policy and receive the lifetime benefit of programs and facility usage for themselves and their spouse (dependents are not eligible for lifetime benefits). Any exceptions to this policy must be presented by the MPD Executive Director and approved by majority of the MPD Commissioners. Motion was made by Vice President Knoll, seconded by Commissioner Hatzenbuhler. Motion passes.
- Discussion on Lil' Haven Park. Public meeting and advertisement is required for sale of property.
 Estimated value of the property is \$30,000. Motion was made by Commissioner Meschke to advertising a public hearing to allow citizens to voice their concerns over closing the park. Seconded by Commissioner Hatzenbuhler. Motion passes.
- Direction on HA Kautzman Park. Director Higlin stated that a citizen appeared before the board to request improvements to HA Kautzman Park. With all the projects currently going on it will be put on hold until spring.
- Update on 19th Street SE trail discussions. Director Higlin stated that the City of Mandan wants to add on to the Stantecs current trail. The cost would be about \$10,000 in engineering fees.
- Update on Foot Golf inaugural kickoff. Brad Olson, golf course manager stated Foot Golf stared Friday
 the 1st of September. So far it's been doing well, they had 33 players that have rented a ball, 30 players
 from the University of Mary's Women's Soccer Team and over 30 players that have brought their own
 ball.

New Business:

Approve the final budget reading of Ordinance No. 1049 making the annual appropriations
expenditures of the Park District of the City of Mandan, North Dakota, for the fiscal year commencing
January 1, 2018, ending December 31, 2018, and making the annual tax levy for the year 2017.
ORDINANCE NO. 1049

AN ORDINANCE MAKING THE ANNUAL APPROPRIATIONS FOR EXPENDITURES OF THE PARKS AND RECREATION DISTRICT OF THE CITY OF MANDAN, NORTH DAKOTA, FOR THE FISCAL YEAR COMMENCING JANUARY 1, 2018, AND ENDING DECEMBER 31, 2018, AND MAKING THE ANNUAL TAX LEVY FOR THE YEAR 2017.

BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE CITY OF MANDAN, NORTH DAKOTA:

Section 1. There are hereby appropriated the following sums of money for so much thereof that may be necessary for the purpose of paying expenditures of the Parks and Recreation District of the City of Mandan, North Dakota, for the fiscal year commencing January 1, 2018, and ending December 31, 2018.

Section 2. There are hereby levied the following sums of money on all taxable property in the City of Mandan, North Dakota, for the year 2018 for the purpose of paying expenditures of the Parks and Recreation District of the City of Mandan, North Dakota.

Capital Improvement Fund	434,024

Section 3. Repeal. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

Section 4. Taking Effect. This ordinance shall be in full force and effect from and after its final passage and adoption.
