Mandan Park District Board Meeting Minutes October 14, 2024

The Board of Park Commissioners met on Monday, October 14, 2024, at City Hall, 205 2nd Ave NW in the Bosch Froelich room.

President Meschke called the meeting to order at approximately 5:30pm, CDT.

<u>Minutes</u>: Motion by Commissioner Mehlhoff and seconded by Commissioner Scott to approve the, 2024 regular meeting minutes. Motion passes 4-0.

<u>Item #1:</u> Director Higlin requested approval to apply for the Transportation Alternatives Grant Program for funding in 2027. The section of trail starts at the intersection of Collins Ave/14th Street NW north to 38th Street/Hwy 1806. The area has water damage from the drainage areas to the west that may require culvert extensions or potentially a bridge. The grant is an 80/20 with the local match special assessed back to the Park District. The local 20% match will be shared 80/20 with the city of Mandan as we are partnering in the grant application together to address shoulder improvements. Motion by Commissioner Mudder and seconded by Commissioner Froehlich to apply for the Transportation Alternative Program and hiring Moore Engineering to design the trail improvements. Motion passes 4-0.

Item # 2. Director Higlin updated the board on recent meetings with Lower Heart Water Resource District (LHWRD). The only change is the discussion from LHWRD to consider pressure relief wells as a secondary option. Director Higlin stated that we would like to send out an informational letter to golfers and citizens as to the proposed flood protection efforts LHWRD is proposing and how they may impact Municipal GC in the future. The board supported a letter detailing the timeline of events and impacts to the district and the golf course. Director Higlin requested board support to hire Burian & Associates to assist with technical items related to flood protection impacting the golf course as a resource to help the Park District. Director Higlin stated that we have funds in the current budget to assist with their services.

Item 3: Director Higlin updated the board on the following projects:

- The boat ramp concrete pad was pushed into the river last Friday and pouring of the remaining sections of the ramp will be completed by early next week. The parking lot stone has been installed and the grid lock system will be installed from the north end to the middle of the parking lot by the end of the month. The contractor will work their way out of the area finishing with the current drive lane areas and entrance. MDU will start boring the electrical this week to tie into our security lights.
- The youth baseball complex field improvements are close for installing turf. Diamond 10 should have turf delivered this week and installation will take place the following week. Fencing on all diamonds support poles and fabric has started along with back stops. The mason has completed the dugouts on diamond 9 along with the back stop, grandstands, and press box. Director Higlin's concern is installation of diamond 9 turf with overnight temperatures dropping below freezing.
